I (we) agree to indemnify, defend and hold the Zapata County Fair Association harmless from any claim for property damage or personal injury in connection with our activities in the 2015 Zapata County Fair Parade. I (we) further covenant not to commence or prosecute any action, suit, or other proceedings against the Zapata County Fair Association as a result of any property damage or personal injury received by participating in the 2015 Zapata County Fair Parade.

This document shall be binding upon (my/our) legal representatives, heirs, successors and assigns. The undersigned has read and voluntarily signed this release, waiver of liability and covenant not to sue and agrees to be bound by its terms.

2015 ZCFA PARADE RULES

1. All parade participants must be registered with parade committee and must submit the release of liability form. Application must include a typed list of all participant names.
2. Drivers of vehicles must be licensed and insured as prescribed by the Texas Dept. of Public Safety.
3. Neither the Zapata County fair Association nor the parade committee is responsible for accidents, thefts, or losses.
4. All decorations will be in acceptable decoration attire.
5. If entries carry music, lyrics must contain adequate and acceptable language.
6. Public officials will ride the parade in representation of their elected public office. Campaigning is not allowed.
7. Trophies for different categories will be issued and will be awarded at the county fairgrounds at 1:30 P.M.
8. Participants will abide by the final decision of the judges.
9. Participants will abide by the location assigned for the line-up.
10. Registration forms need to be received by March 10, 2015 in order to participate in the parade.
11. Car clubs will be allowed to enter three (3) of their show cars (this includes representation from car wash businesses, body shops, etc.)
12. Drivers will not swerve off the highway or side to side. Everyone will follow a straight line-up and will drive at the required speed limit. There will be no passing of floats or vehicles during the parade.
13. Motorcycle clubs are allowed in groups of six. If there are more entries, they will be placed in different sections of the parade. Motorcycle drivers are not allowed to get close to the edge of the highway where the audience is present. No swerving and no passing cars or floats.

***Notice: Floats and other vehicles will start lining up at 7:00 a.m. on 3rd Ave. (Street of Pepe's Car Wash) and must be in line and ready to start by 8:30 a.m. Parade participants riding on floats must be aboard their floats by 8:45 a.m.**
